# **Policy and Advocacy**

#### Policy Working Group (PWG)

 discuss, initiate and implement policyrelated activities of the EATG to improve access to treatment, care and prevention with focus on different vulnerable populations, human rights, access and innovation etc.



#### <u>Activities</u>:

- Informs EU policy making relating to HIV/AIDS (work with EC and EP)
- monitors political health agenda of the EU institutions
- leads and participates in other policy related public health initiatives and projects

# Science, research and drug development

**European Community Advisory Board (ECAB):** harmonisation of the best available clinical practices, standards of care and access to the latest and best available therapies and diagnostic tools throughout Europe via:

- Clinical research and drug development
- Clinical trial protocols
- Best practices procedures and ethics
- Universal access to fair, sustainable, affordable drugs
- Access to prevention and substitution treatment

**Priority areas:** HIV, co-infections (HCV, TB, HBV)



# Science, research and drug development - Projects

- EUPATI: patient-led academy that will provide scientifically reliable, objective, comprehensive information to patients on pharmaceutical R&D
- EmERGE: Develop a mHealth platform to enable self-management of HIV in patients with stable disease (app development).
- EHVA: The European HIV Vaccine Alliance (EHVA) program has as major goal to develop a Multidisciplinary Vaccine Platform (MVP) in the fields of prophylactic and therapeutic HIV vaccines. The MVP includes four components: 1) Discovery, 2) Immune Profiling, 3) Data Management, Integration and Down-Selection, and 4) Clinical Trials.
- EUROCOORD: a Network of Excellence of the biggest HIV cohorts and collaborations within Europe


Building, fostering and supporting synergies among and capacities of local HIV community organizations across Europe

# **EATG internal structure**

- **General Assembly**: representation of all EATG members highest decision-making body
- Board of Directors: executive board chosen by the membership
- Staff: supports EATG functioning
